



Dear Parent or Guardian,

Your child is eligible to participate in our online **After School Credit Recovery (ASCR) Program** as an option for recovering lost credits for courses failed in previous semesters. Klein ISD utilizes the **Edgenuity** program of online credit recovery. Edgenuity provides self-paced, TEKS-aligned, online courses that allow students to work both at school and off campus via their website. There is **no cost** to participate in the after school program.

A teacher monitored lab will be open **Monday – Thursdays 2:40 – 5:00 pm**. Students will sign up for days on a first-come, first-served basis, and must commit to attending at least **two assigned days a week** until the courses needed are completed. Students needing to recover more than two credits should consider signing up for additional days. When the program is full, we will maintain a waiting list and bring new students in when others have completed their courses. Students who acquire more than two unexcused absences may lose their opportunity to attend ASCR. All students need to bring their KISD issued computer, supplies and headphones to each session.

Students should plan on each course taking approximately 25-30 to complete at their own pace. Students may work on **credit recovery at home** (highly recommend), therefore they can focus their energy after school working on quizzes and exams which must be taken in the presence of their credit recovery teacher.

Upon completion of courses, students receive a grade of “P” (pass) and credit for the course on their KISD transcript.

If your child wishes to participate in this program, please complete the attached form and return it ASAP to his/her counselor. Once the form is returned, the student’s counselor will confirm the courses needed. When I receive the enrollment form, the student will then receive a student confirmation indicating the days he/or she is schedule to attend or notification if placed on a waiting list.
