

Klein ISD Tablet PC Parent/Student Agreement Form 2018-2019 KO

I am aware of the terms set forth in the Klein ISD Student Tablet PC Handbook for Klein Oak. I understand and will comply with all of the conditions outlined within. Parents, please read and initial the following:

_____ I understand that my student must report any needed repairs, loss, or damage to the Tablet PC or any peripheral items (including a case number) within 5 school days from time of occurrence, otherwise I may be liable for any cost incurred by the district to repair or replace the Tablet PC or peripheral items.

_____ I have received and understand that I am bound by the terms and conditions stated in the 2018-2019 Klein ISD Student Tablet PC Handbook for Klein Oak.

_____ I understand that if I fail to return the Tablet PC or any peripheral items at the end of the school year or upon transfer or withdrawal from a Klein ISD campus, district records may be withheld and I may be subject to criminal prosecution.

_____ I choose not to purchase a Klein ISD-provided case. I understand that Klein ISD will issue a case to me to be used for multiple years (including holding the case over the summer), as long as the case can be used with the Tablet PC model issued to me. I further understand that I must maintain the case in acceptable condition and return it when the case can no longer be used with the Tablet PC model issued to me or upon transfer, withdrawal, or promotion/graduation from a campus. I accept responsibility for the cost to repair or replace the case in the event of damage, loss, or theft.

If I elect to purchase a Klein ISD-provided case as set forth in the Klein ISD Student Tablet PC Handbook for Klein Oak, I understand that I must contact the campus repair center to make payment and that payment must be made in full before the case will be issued.

Please initial one (1) of the following options:

_____ I am purchasing the Accidental Damage and Protection Coverage (ADPC) for \$65.00 (covers up to three incidents of accidental loss or damage to the Tablet PC per year; does not cover loss/damage that is either intentional or the result of gross negligence or peripheral items, such as stylus, charger/power adapter, battery, and case).

_____ I choose not to purchase the Accidental Damage and Protection Coverage and will assume full responsibility for the costs associated with repair and replacement of the Tablet PC and any component or peripheral item. Because I have chosen not to purchase the Accidental Damage and Protection Coverage, I will remit a \$350.00 Security Deposit to Klein ISD. The \$350.00 Tablet PC Security Deposit is ***fully refundable*** at the end of the school year (or when a student withdraws from school) ***after the Tablet PC and all peripheral items are returned to Klein ISD in acceptable condition (please note that it may take up to 15 District business days after receipt of the Tablet PC and all peripheral items for Klein ISD to issue a refund)***. If the Tablet PC and all peripheral items are not returned to Klein ISD in acceptable condition, the \$350.00 Tablet PC Security Deposit will be applied to all outstanding charges for repair or replacement of the Tablet PC and any peripheral items. **In the event charges exceed \$350.00, I will be responsible for the entire repair or replacement charge in excess of the \$350.00 Tablet PC Security Deposit.**
